The board of directors ("**Board**") of the Company is pleased to announce that the Listing Executive Committee ("**LEC**") of the Stock Exchange of Mauritius Ltd (the "**SEM**") has, on 17 March 2016, granted its approval to proceed with the issue and listing of up to 20,306,455 new ordinary shares of no par value of CMB International on the Official List of the SEM by way of private placement and this will be deducted from the quantum that was approved by the LEC on 9 October 2015, i.e. 244,901,620 ordinary shares.

PRIVATE PLACEMENT OF SHARES

The Company has successfully raised USD 2,030,645 by way of a private placement of shares to invited investors ("**the private placement**"). Through the private placement, the Company has placed 20,306,455 new CMB International shares with investors ("**the new CMB International shares**") at USD 0.10 per share, through the Company's Mauritian share register.

The new CMB International shares are expected to list and trade on the Official List of the SEM and on the Main Board of the Namibian Stock Exchange ("**NSX**") from 22 March 2016.

The new CMB International shares will rank *pari passu* in all respects with existing shares in issue. Following the issue of the new CMB International shares, the Company will have a total of 217 133 154 shares in issue.

For a full appreciation of the Company, the Supplement to the Listing Particulars relating to the private placement and the Listing Particulars of the Company dated 9 October 2015, should be read in their entirety.

As required by the Listing Rules of the SEM, copies of the Supplement to the Listing Particulars and the Listing Particulars of the Company, will be made available for inspection for at least 14 days during normal office hours (from 9 a.m. to 5 p.m. Mauritian time) at the registered office of the Company which is situated at Level 3, Alexander House, 35 Cybercity, Ebene 72201, Mauritius as from 17 March 2016.
